Students who do not meet the prerequisite will be deregistered from the course.**Class Times:** Class meets from 12:05–12:55PM; Thursday in MSB 114; Wednesday and Friday in HND 201**Course Materials:** Our text is **Calculus for Business, Economics, Life Sciences, and Social Sciences**, 13th edition, by Barnett, Ziegler, and Byleen. A loose-leaf, binder-ready, version of the book comes with a **MyLabsPlus** Access Code which is required in order to do the homework. These are available bundled at the KSU bookstore for \$147 or from Pearson directly, here, currently priced at \$103. A temporary access code is available that will work for the first two weeks of class. A graphing calculator will **not** be required for the course, and will be prohibited during certain exams and quizzes. However, if you wish to use one during other times then I will be able to offer assistance with the TI-83 or 84 graphing calculator.**MyLabsPlus:** Homework will be completed on the software that accompanies the text, MyLabsPlus (MLP). **Homework:** You will complete all homework assignments on MyLabsPlus, the computer software that accompanies our text. You should keep a notebook showing all work for these assignments to help you study. Assignments will be due by midnight on Sunday. Students may continue to work on the assignment after the due date for a 2% penalty per day until the day of the exam.**Quizzes:** You will have a quiz at least once a week, generally on your lab day, unless we have an exam scheduled for that week. Quizzes may either be in MLP or on paper.**Gateway Exams:** There will be two gateway exams testing the mathematical skills of differentiation and integration. The exams are graded as a pass for anything over 80% and a fail otherwise. You will receive multiple attempts to take the exam.**Final Exam:** The final exam is a cumulative exam which will be held **Monday, December 8th, from 10:15-12:30PM**.
